Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

This was a data review of waste returns submitted in 2023, and subsequently a check on all waste returns submitted for this site to NRW since Q4 2014.

The site permit and associated Waste Recovery Plan permits a total of 116,500T to be deposited on site as part of the 'Deposit for Recovery' permit.

An audit of the waste returns showed that a total of waste accepted on site was 378,118.4T since 2014. The total of waste removed off site was 33,457.1T leaving an amount of 344,661.3T unaccounted for.

This apparent discrepancy can be explained by the waste treatment/transfer station included on this permit. This part of the permit treats inert waste to a standard under the WRAP Quality Protocol so that it has met End of Waste status and is now classed as a product so would not be included on the waste returns as 'Waste Removed'. As such it looks as though there is vast quantities of waste material on site, however, this is not the case.

Should ASH require there to be any amendments to the permit and WRP on site this must be done through a permit variation.
