**4. Details of our assessment**

This Compliance Assessment Report (CAR) has been issued in response to the submission of the Q2 (April - June) 2024 monitoring returns by RWE Generation UK plc (the operator) for activities at Pembroke Power Station, West Pennar, Pembroke, Pembrokeshire, SA71 5SS under permit EPR-DP3333TA.

**Q2 2024 Monitoring Returns****Releases to water** - *Water 1 (10/11/11)*

The returns for reporting of sampling and analysis of emissions to water (other than sewer) to emission points W1, W1 (a), W1 (b), W1 (c), and W2 for Q2 (1 April - 30 June) 2024 were submitted to NRW by the operator on 11 July 2024.

**Releases to air** - *IED/LCPBREF CON2 (Gas turbines) and IED/LCPBREF PM1*

The monitoring return results were submitted to NRW by the operator on 11 July 2024 for LCP286 (Unit 11), LCP382 (Unit 21), LCP383 (Unit 31), LCP384 (Unit 41), and LCP385 (Unit 51).

- The data was sent within the Q2 reporting period, which is **compliant** with permit condition 4.2.3.
- The monitoring was undertaken within the Q2 monitoring period, which is **compliant** with permit condition 3.5.1.
- Based on the reports submitted by the operator, emissions at the monitoring points for Nitrous Oxide (NO<sub>x</sub>), Sulphur Dioxide (SO<sub>2</sub>), and Carbon Monoxide (CO) appear **compliant** with the site's specified emission limits over the Q2 reporting period.
- Based on the reports submitted by the operator, all other emissions at the monitoring points appear **compliant** with the specified emission limits over the Q2 reporting period.
