4. Details of our assessment

On Wednesday the 3rd of June 2024 Ian Thomas, Waste Regulation Officer, carried out an unannounced routine site inspection at Bagillt Car Spares. The weather was fine and dry.

During the inspection the officer was accompanied by the owners, Michael Waugh and Peter Duffy. The yard was quite full with a number of ELVs, Several depolluted vehicles stored on permeable ground were checked and did not observe any issues.

Since the last visit the processes of the site have been vastly improved. All engines and gearboxes are now removed and there are 2 large skips outside the depollution area where engines are loaded into one, and gearboxes into the other. The skips are covered at the end of each day. These are collected by Lelo and removed from site. The car shells are then stored in the top area of the site and sent to Naughtons.

There was small oil spill at the entrance to the depollution area. This was due to the engines being loaded into the skips. A review of the waste return submissions has been completed and were up to date. Waste transfer notes are recorded and stored as required. No other issues were apparent.
