4. Details of our assessment

This CAR acts as a continuation of CAR_NRW0043099 in which there was an EDM data request. This was submitted within the given timeframe and demonstrates **compliance with Condition 3.1.**

Upon review of the data submitted, alongside rain gauge and river level data surrounding the time period in question, it is considered likely that the asset was operating within permitted storm discharge conditions on the date in question - 26th December 2023.

However, in line with the below condition(s) a further query remains regarding storage capacity for storm sewage. Please see actions below.

Condition 2.3.2 (b) *Off-line storm storage must be fully utilised before a discharge occurs. It shall only fill when the flow passed forward is equal to or greater than the overflow setting indicated due to rainfall and/or snow melt and shall be emptied and its contents returned to the continuation flow as soon as is reasonably practicable. The minimum off-line storage storage required is specified in Table S3.3.*

Condition 2.3.2 (c) *On-line storm storage must be fully utilised before a discharge occurs. It shall only fill with the excess flows due to rainfall and/or snow melt. The storage shall be emptied and its contents returned to the continuation flow as soon as reasonably practicable. The minimum on-line storm storage required is specified in table S3.3.*
