4. Details of our assessment

A self reporting watpol was received on the 7/6/24 with reference to 2 spills on the 6/6/24 (total of 1h40) and 7/6/24 (total of 1hr15). There was no noted impact and no clean up needed.

DCWW self-report submitted for brief spill from site during low flow. High sump level alarm came in, operator attended site and found the pump was running but not passing flow forward. Pump was switched off and the duty changed to pump no.2 which then pumped through the night then tripped.

Subsequent information from DCWW - it was found that couple of control fuses had blown affecting both pumps. Fuses were replaced, further investigation found that the windings on pump no.1 were out of balance, pump has since been changed and old pump sent to framework supplies for overhaul/ replacement. We have also replaced some of the contactors inside the panel as these were deemed suspect.

An alarm review has highlighted additional alarms to be added and the pump duty change-over to be automated if the flow is less than required and the well level is high.

Using Guidance 16_02, this issue is considered to fall under a. Electrical failure of process control systems - which is not covered by the permit
