**4. Details of our assessment**

This Compliance Assessment Report (CAR) has been issued in response to the submission of the Q3 (July to September) 2024 monitoring returns by Morganite Electrical Carbon Limited for activities at Electrical Carbon Swansea, Upper Fforest Way, Morriston, Swansea, SA6 8PP under permit number EPR/VP3339PD.

**Reporting of Emissions to Air for the period from July 2024 to September 2024**

Schedule 4 of the permit outlines the reporting requirements – emissions to air parameters as required by condition 3.5.1 from emission points A10\*, A15, A19, A27, A28, A61 every 12 months from 01/07/2005.

*\*Emission point A10 and the associated process was decommissioned in March 2024. There is currently a permit variation in the process of being determined which includes the removal of this emission point. Therefore, there is no requirement to report data for this redundant emission point.*

The returns for reporting of sampling and analysis of emissions to air for Q3 2024 were submitted on 27 August 2024, within the reporting period, in compliance with permit condition 4.2.3. The returns were reported in the correct reporting format as outlined in Table S4.4.
