This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

A pre-arranged site familiarisation visit of the Tata Shotton Landfill (permit reference GP3030BE) by NRW officers, required access to the effluent treatment plant (ETP) to assess the landfill leachate management element of the process.

During the visit, a fuel spill was observed on the permeable hardcore covering in an un-bunded area of the ETP. It was evident that the spill whilst very recent had not immediately occurred and there was no apparent source of the spill present. Subsequent enquiries indicated that the spill was from heavy plant, possibly operated by a third party contractor which had been removed from the area prior to our arrival. No apparent measures had been implemented to manage the spill. **This is a breach of Condition 3.2.1 of the Permit and a Category 3 score has been applied.**

The NRW officer highlighted the spill to the Operator representative who confirmed that they had not received a notification that the spill had occurred. The Operator representative has provided the relevant spill procedure. A review of the spill procedure identifies a failing to follow the procedure. **This is a breach of Condition 1.1.1 of the Permit and a Category 3 score has been applied.**

Actions

1. Review and update procedures and associated training to ensure that all operatives, including contractors are aware of their responsibilities and the procedure for mitigating and reporting environmental incidents, including but not limited to spills and leaks. **Provide NRW with evidence of updated procedures and provision of training by 30 September 2024.**
2. Summarise actions taken to mitigate the impact of the spill and provide to **NRW by 30 September 2024.**
