4. Details of our assessment

GROUNDWATER BOREHOLE 26 B - High Ammonia Readings/TDL QUARTERLY SURVEYS

GWBH 26B has been showing high levels of ammonia for a number of years but is not included in the monitoring schedule to the permit. This means that there is not a permit breach despite the high levels of ammonia detected.

During the site meeting and subsequent assessment of the area around the borehole it was determined that this monitoring point is probably disconnected from the Dulas Valley Spring hydrogeology as the spring is below the detection limit for ammonia as demonstrated by the recent monitoring undertaken by and on behalf of FCC as required by the permit.

Following a discussion with Steve Croker of FCC it was decided that this borehole possibly acts as a sentinel for Phase 1a of the site which is the only part of the landfill that is unlined (in terms of LFD compliant lining systems.) Therefore it is important to retain a monitoring schedule for this borehole pending further review.

Attendance at the borehole during the next schedule monitoring round is desirable with NRW if timings align.

TDL SURVEYS

TDL surveys of infrastructure have moved to quarterly compared to historically being performed on a monthly basis. FCC have proposed to move back to monthly and the three breaches of the 1000ppm limit consecutively leading to CCS scoring. This provides a useful audit tool for ensuring the gas extraction system is maintained and performs according to design and permit conditions.
