4. Details of our assessment

This report details the site visit made on the 2nd September 2024 to A1 Skips, Newport, permit reference number EPR-FP3295FN.

Natural Resources Wales (NRW) Officer Greg GARDNER, Officer Chris BURGE and Enforcement apprentice Mark O'GORMAN attended the A1 Skips site at Alexandra Docks, West Way Road, Newport, NP20 2UW for a routine unannounced site inspection at 12.20pm where we met with the Site Manager, Mr. Robert TIERNEY. The weather was dry, cloudy and reasonably mild.

PERMIT INSPECTION

Operations were on going at site during the time of the site inspection. Waste was visible only in the operating areas. NRW enforcement apprentice Mark O'GORMAN was introduced to Mr. Robert TIERNEY who is the site manager of A1 Waste Management. Mr TIERNEY provided an in depth tour of the site and explained in details operating procedures. During the tour we were shown the newly installed material picking line, which has been operational for 3 weeks. See photo 1,2,3

Towards the rear of the site there was a pile of waste material being prepped for processing, it did not exceed 4 metres in height and appeared perfectly in line with permit regulations and FPMP. Mr. Tierney explained that this material deposit will be greatly reduced within the next few weeks to keep the yard as clean as possible. See photo 4 & 5.

Drainage on site is via an interceptor which was operational at the time of the inspection and cleaned periodically. There was no excessive noise along with no airborne dust present during the site inspection. There was also no offensive odours witnessed by NRW Officers. Site

security was of no concern either.
