On 03/09/2024 Natural Resources Wales Environment Officer Ceri Malone attended the

site to conduct a routine site inspection of the package treatment plant (PTP) and reed bed system (EPR/CB3893CC) at Beic Parcio Cymru (BPC). The Health and Safety (H&S) Manager for BPC was in attendance. An engineer from Filta Group was also present servicing and sampling the outfall of another PTP on site (EPR/AB3591CP). The weather was dry with moderate cloud cover, around 18°C. BPC was closed on this day to visitors, this was a routine closure as part of their normal operating hours.

The BPC H&S Manager informed me that the PTP is not currently installed as it is part of a planned expansion of the site over the next ≥ 18 months. Currently the site expansion is limited to car park construction only. No facilities or foul drainage associated with the PTP has been installed.
