Unannounced site inspection undertaken by Michael Edwards of Natural Resources Wales met with Paul Perry on site.

Following the inspection the admin variation for the acceptance of catalytic converters (16 01 21\*) has now been submitted.

### **G4 Reporting and notification to Natural Resources Wales**

A review of the waste returns for 2017 has been undertaken and it has been noted that the site as reported several waste types that are not permitted under the current **permit condition 2.3.1** and **table S2.1**.

Waste codes used in the returns are **060104, 160601, 160121 and 170203**.

**This has been scored as a category 4 breach of permit condition 2.3.1.**

**Action** - Please ensure that you only accept permitted waste types under the permit conditions or provide evidence that shows the above codes are entered as an admin error.

### **C4 Storage, handling, labelling and segregation. and B4 Containment of stored materials.**

All wastes were stored on impermeable surfaces with sealed drainage as required under **permit condition 2.1.1** and **table S1.1**. Batteries accepted onto site for storage only and are stored within appropriate containers, as required under **table S1.1**. The boxes are stored in the main warehouse which has an impermeable surface.

No treatment of WEEE takes place on site inline with **condition 2.1.1** and **table S1.1**.

### **C1 Staff competency/ training**

Under **condition 1.1.1 (b)** of the environmental permit. The operator must manage and operate activities using sufficient competent persons and resources. Staff training records were reviewed during the inspection and no issues were identified.
