## 4. Details of our assessment

Natural Resources Wales Senior Industry and Waste Regulation Officers Carter Shone and Phil Harper visited St Asaph Infar Red, Qioptiq Limited, Glascoed Road, St Asaph, Denbighshire, LL17 0LL at 1000 on the 5th September 2024. This was an announced inspection as part of a site familiarization.

### Permitted activities

The officers were given an in depth tour of the site including all of the permitted emission points and shown the new segregated waste systems.

No issues were identified during the inspection.

The operator recently undertook an ecological survey of the green space around the site, to gain an understanding of how that could be used to benefit the environment, including wild flower areas, insect habitats and bird boxes.

This is an example of an operator going above their environmental requirements, to achieve sustainable management of natural resources (SMNR).

### Emissions to water, air or land

During a review of the operators annual monitoring (CAR\_NRW0043405), it was identified that they were close to their emission limits on emission point A5.

To address this, the operator has replaced the equipment associated with A5, resulting in, the emission point becoming redundant with no equipment connected to it.

NRW officers advised that because this change has no environmental impact (environmental impact has been reduced). The emission point can be removed in a future variation when the operator next varies the permit.

NRW officers agreed there was no need for future monitoring to take place of emission point A5.
