### 4. Details of our assessment

We are issuing the compliance form based on legacy guidance OI238\_03. There was an

initial permitted exceedance in 2022, then the result of >143 mg/l on 5th June 2023 is the 2<sup>nd</sup> exceedance for BOD at this site within the last 12-month period, then the result of 126 mg/l on 27th June 2023. This would be the 2<sup>nd</sup> failure, therefore a Category 1 according to this guidance.

BOD results summarised below:

- 21/09/2022 - >145mg/l
- 05/06/2023 - >143mg/l
- 27/06/2023 - 126mg/l

3 of 5 samples over the limit in 12 months.
