4. Details of our assessment

This CAR form is retrospectively issued to provide a record. This information was passed to Steve Churches via e-mail on the 27 February 2024.

On the 15 February 2024 Chris Palmer, Owen Caughlin and Rhys Griffiths were performing field work on the River Neath at Cwmgrach and noticed the outfall from Cwmgrach STW had

collapsed and fallen into the river. This appeared to be a result of the river undermining the outfall and bank.



This is a breach of condition A of the current permit. The dispersion of the discharge will be greatly effected as well as a risk of discharging to the dry riverbed in low flow conditions.

(a) the Welsh Water Authority submitted an application to the Secretary of State dated 24 March 1989 [as supplemented on in accordance with section 311 of the Control of Pollution Act 1974, as modified by the Control of pollution (Discharges by Authorities) Regulations 19814, to discharge sewage effluent into the River Neath from the Cwmgrach Sewage Treatment Works at National Grid Reference SN 8627 0547 ("the proposed discharge");

ACTION - Provide plan to repair and reinstate outfall - 12/11/2024

A full inspection of Cwmgrach STW was undertaken on the 10 September 2024 where this issue was discussed. At that time it was unknown if a plan had been put in place to fix.
