4. Details of our assessment

This compliance assessment report (CAR) has been raised following a routine, pre-arranged site inspection. We were accompanied throughout the visit by the Health and Safety Manager and the Environmental Officer.

We visited the effluent treatment plant (ETP) and viewed the HMI and tank level board. The following readings were observed at the discharge point:

Suspended solids - 4.1mg/l

Temperature - 20°C

pH - 6.8

Flow - 16.9m³/hr

Total discharged - 469.7m³

All were compliant with the emission limit values detailed in the permit. A copy of the average results from the final effluent from June to September was provided during the visit. The results are detailed below:

COD - 32.8mg/l

TSS - 8.5 mg/l

NH₃-N - 0.06 mg/l

PO₄-P - 0.15 mg/l

Temp - 25.7°C

BOD - 1.5 mg/l

These results are well below the ELV's in the permit and demonstrate how the improvements to the ETP and its management have been effective.

Further improvements to the ETP have been implemented since the last site inspection including the installation of a 2mm screen for incoming effluent and a 0.5mm screen into the balance tank. This has been effective in reducing the load into the ETP. This screening waste is removed off site as CAT 3 ABP. The emergency pits were empty and the ETP area clean and tidy.

The concreted bunded area around the ETP is now 95% complete and 24/7 cover is being maintained on the ETP.

Further improvements have been made to reducing the noise of the site with further noise attenuation works planned to start on 16/09/24. There was no significant noise from the site whilst we walked around the external areas. A very mild transient odour was occasionally detected whilst walking around the site but no off site odour was detected.

The site confirmed they are still running below 1 million birds per week and will notify us when they intend to increase production.
