Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

4. Details of our assessment

This was a routine pre-arranged inspection with a more detailed focus on the management of the Effluent Treatment Plant (ETP). This was due to receiving several Part A notifications for breach of the suspended solids limit over several days in June. The site provided an overview of the ETP process and how they have implemented several actions to assist the ETP in achieving the consent limits when there are stop/starts in production and the ETP not receiving a steady stream of effluent. This will become more important over the coming months as production starts to reduce and they commence shutdown of Coleshill Mill.

The site have been working closely with their nutrient supplier to ensure optimum nutrient dosing is achieved with the different fluctuations in effluent . This will enable the ETP to work effectively and ensure consent limits are not breached in the future. A plan for the stop/start of the ETP has been provided.

The ETP was viewed and an outline plan of how the plant will be shut down as production ends was discussed. Incoming effluent is sampled twice a day from the aeration tank and tested in the in-house laboratory which was viewed during the inspection. Treated effluent is tested daily from the Treated Effluent Tank (TET) to ensure the treatment process is removing contaminants to comply with the emission limit values (ELV) specified in the permit. If there was an issue with an ELV at the TET this can be pumped back to the combined balance tank for further treatment. Sampling plans and results were viewed during the visit.

Phosphorus levels are tested weekly in the treated effluent to ensure compliance with the annual ELV's. The microbiology of the sludge is checked on a weekly basis by a competent and experienced member of staff to ensure it is healthy.

Schedule 5 Notifications

A Schedule 5 Part B notification was received on 20th August 2024 for the suspended solids breaches in June:

Root cause problem solve carried out.

Identified 3 factors for actions to be set against:

- using a new alternative coagulant
- increasing nutrient dosing
- tissue machine stop/start plan.

All actions have been completed.
