4. Details of our assessment

This Compliance Assessment Report has been raised following a routine pre-arranged site inspection. The Group Lead Operations Manager and Quality Compliance Manager accompanied us around the site. The site was well managed, ordered and tidy at the time of the inspection.

The annual air emissions monitoring was being undertaken during the inspection.

Work to extend and improve the vehicle wash area including an extra interceptor has not yet been completed but the site has provided a date of the end of March 2025 when this work will be complete. As mentioned on a number of previous inspections, there is the potential for vehicle wash run off to enter the unmade ground which surrounds this area. Failure to complete this work will attract a compliance score in future inspections.

The draw off pipe from the soya oil and rhodimet tanks are outside of the bunded area. There is a risk of spillage from this pipe so it should either be within the bunded area or separate containment installed. (CIRIA C736 provides further guidance). This is important as there are surface water drains in close proximity to these tanks and the site drainage is not fully contained.

A Combined Heat and Power (CHP) plant has been installed inside the site to provide electricity. The CHP is gas powered and rated at 1.3MW thermal input with an extra emission point. Hot water generated from this process is then fed back to the steam generating boiler. This has not been included on the current permit.

This is in breach of Permit Condition 2.1.1, Schedule 1, Table S1.1 (the activities) and a Category 3 score has been applied.

Action

Apply for a permit variation to include this activity and extra emission point by 29th November 2024.

Further information and guidance on the variation process will be provided separately.

An odour could be detected on site at the time of the visit and was linked to the facility. No

odour was detected outside of the site boundary and to date no odour complaints had been received about the facility.
