The Compliance Assessment Report (CAR) has been generated by Natural Resources Wales (NRW) following the submission of the Q2 monitoring returns.

Q2 Monitoring Returns (April to June 2024) - Emissions to Water

The Q2 Returns for April, May and June were submitted on 16/08/24. The late returns are a **breach of Condition 4.2.3 and have been scored a C4.**

April 2024 - Returns did not report any exceedances of the emission limits specified in Condition 3.1.2 and Table S3.2 for emission point W1.

May 2024 - Returns did not report any exceedances of the emission limits specified in Condition 3.1.2 and Table S3.2 for emission point W1.

June 2024 - Returns did not report any exceedances of the emission limits specified in Condition 3.1.2 and Table S3.2 for emission point W1.

ACTION 1: Returns are to be submitted as specified in Condition 4.2.3 *within 28 days of the end of the reporting period.*

A permit variation application for the incorporation of a Ferric Dosing System to the effluent treatment plant was determined on the 12 August 2024 (Permit Reference EPR/AB3697CN/V004).
