4. Details of our assessment

On 08 May 2024, Natural Resources Wales (NRW) received a report from a member of the public stating that Dŵr Cymru Welsh Water (DCWW) asset was discharging into the Afon Teifi in Newcastle Emlyn at SN 30876 40797. The report stated that both pipes at this location were discharging at the time of the report and that there was a slight sewage odour but no debris present. The report also stated that there had not been any rainfall in the area that day.

NRW notified DCWW via a POLFAX, which was logged with DCWW (SAP number 316923223). DCWW attended site and confirmed that 1 Teifi Terrace Combined Sewer Overflow (CSO) Newcastle Emlyn (permit number MP3425XC) was discharging due to a blockage on the main line downstream of the CSO. This blockage had been caused by wet wipes and blue roll.

Condition 2.3.1(a) of 1 Teifi Terrace CSO Newcastle Emlyn permit MP3425XC states that a discharge from the CSO *'shall only occur when and only for as long as either: (i) the flow passed forward is equal to or greater than the overflow setting indicated (23.608l/s) due to rainfall and/or snow melt or (ii) the hydraulic capacity of the sewer network downstream of the combined sewer overflow is reached due to rainfall and/or snow melt and the level of storm sewage in the sewer at the combined sewer overflow is greater than the weir level of the overflow structure which is specified as an overflow setting in table S3.3 (23.608l/s). The capacity of the sewer network downstream of the combined sewer overflow shall not be altered in any way which would lead to a significant increase in the frequency or volume of the discharge'*.

As the discharge from 1 Teifi Terrace CSO Newcastle Emlyn that occurred on 08 May 2024 was not as a result of rainfall and/or snow melt, but was due to a blockage caused by wet wipes and blue roll, this discharge represents a breach of permit. The breach has been recorded as a category 3 non-compliance, defined as a non-compliance which has the potential to have a minor or minimal impact or effect on the environment, people and/or property.

In response to this NRW ask DCWW to (1) Supply the Event Duration Monitoring (EDM) data for 1 Teifi Terrace CSO Newcastle Emlyn for the period 01 May 2024 – 15 May 2024 and (2) Outline what planned maintenance was carried out on 07 May 2024 and how often this maintenance is carried out at 1 Teifi Terrace CSO Newcastle Emlyn. NRW ask DCWW to complete this by no later than the **20 November 2024**.

In this document 'Natural Resources Wales' means the Natural Resources Body for Wales established by Article 3 of the Natural Resources Body for Wales (Establishment) order 2012.
