4. Details of our assessment

In response to **CAR_NRW0043981, Action - Please advise us of how long the EDM monitor has been broken/out of action? Please carry out repairs to EDM monitor,** DCWW have advised that the EDM monitor stopped working in November 2023 and was flatlining at 1780%. An investigation was carried out to identify the issue with the monitor and it was found to be not operating due to moisture damage and as a result needed replacing. A contractor was instructed to complete the work to replace the monitor with a Vega monitor which includes a radar level and verification probe. This work was completed on 6th March and the EDM has been operational since.

We are satisfied that this action is now complete however we are aware that **CAR_NRW0043981** also included **Action- Please survey the storm tank and carry out repairs needed e.g repair leak** which is still outstanding.
