### 4. Details of our assessment

In response to **CAR\_NRW0043886**, **Action - Survey final settlement tank and carry out repairs**, DCWW have advised that a survey has been carried out on the final settlement tank which identified leaks across the weir however the impact of the leaks was also assessed and it was found that they are not currently having a significant effect on the overall performance of the tank. DCWW Operational staff visit the site five days a week to monitor final effluent (FE) compliance and they are trained to observe and report any potential compliance issues, including those that might be related to the performance of the final settlement tank, and as there is only one final settlement tank onsite, carrying out repairs would present considerable challenges including significant costs. Therefore DCWW have decided to add the final settlement tank to their investment register for future

capital investment.

As the issue does not seem to be having a significant impact on the final effluent produced, we are satisfied with this response knowing that it has been added to the register for future investment.

We are aware that **Action - Investigate what is causing the fungal growth and carry out repairs if needed** included in **CAR\_NRW0043886** is still outstanding.
