4. Details of our assessment

Routine site inspection of Rockfield Wastewater Treatment Works carried out by Environment Officer Peter Jones. On the day of the inspection, It was bright sunshine with no rain. There had

been significant rain within the last 48 hours.

The current permit was issued in 1992, the site is designed for a population equivalent of 250. It's a descriptive permit with a maximum daily flow of 55 cubic metres per day.

Effluent enters the works and flows into a Primary Settlement Tank (PST). From the PST the effluent flows to a small filter bed. This is currently not operational; the filter arms are failing to rotate and distribute the effluent across the filter medium. Effluent from the PST is not flow onto the wheel which carries the effluent to the filter arms. There is significant build-up of solid matter in the filter arms. The works has not been maintained and this is a breach of condition 8.a and 8.b.

Condition 8 The works shall be operated and maintained in accordance with the manufacturer's instructions. In particular, the works shall be maintained such that:

- a. It remains fully operational except at times of mechanical or electrical break down.
- b. Any such breakdowns shall be attended to promptly and the equipment returned to normal operation as soon as possible.

From the filter bed the effluent flows into a humus tank, solids are building up on the surface of the effluent in the tank. The effluent passing beneath the baffle is grey in colour and looks to have a high turbidity.

The final effluent point is clearly marked. A sample of the final effluent was not collected.
