4. Details of our assessment

Site Report

On Tuesday 10th September 2024 I visited Tarmac Trading Limited, Trefil Quarry, Tredegar NP22 4HF to carry out a permit inspection on their Trade Effluent Plant. Permit Number AC0121201. I arrived on site at 9.25. The weather conditions were cloudy with light rain. My Site inspection commenced at 9.30.

Observations

I proceeded with a general walk around the site. General walk around the site confirmed

fire extinguishers and spill kits were in place. Please see Fig 1, 2 and 3 below.

I proceeded to identify the location of the Trade Effluent Plant settling bays. Please see Fig 4, 5 and 6 below.

After identifying the location of the Trade Effluent Plant settling bays I checked the sample point location. The sample point was an outlet from the final settlement bay at NGR SO 12106 13100. I confirmed this accurate as stipulated by the permit. Please see Fig 7 and 8 below.

I visually checked the stages of treatment of the Trade Effluent Plant settling bays and confirmed that the plant was operating as designed. The water discharging from the outlet was clear with no odours present. Please see Fig 9 below.

I proceeded to check the discharge point at NGR SO 1190 1286. There was no discharge present at the time of my visit.
