### 3. What will happen next?

### 4. Details of our assessment

On 14th August 2024 a compliance audit sample was taken at the site. Following analysis, the Suspended Solids concentration was found to be in breach of parameter limits.

The Suspended Solids result was 32 milligram per litre of a parameter that shall not exceed

30 milligrams per litre.

The impact from the discharge is likely to be a category 4, which has no potential environmental effect.

On this occasion there are no further actions to complete, however we ask that you continue to monitor the discharge of sewage effluent as well as the maintenance of the system in light of the recent failures within the Bioclere Sewage Treatment Plant system.
