4. Details of our assessment

On Friday 6th September 2024 Natural Resources Wales officers attended site.

This was a routine site inspection for permit ref EPR/WP3394FG which was carried out by Waste Regulation Officer Ian Thomas.

On arrival at site, i met with site operative Jonny Rider, Operations Manager Charles Whyte was not on site. Jonny showed me the files of paperwork in the office. All waste transfer notes were available for both Waste and Haz waste, all paperwork looked to be in order.

As with previous inspections, heavy plant machinery is in use to move vehicles around the storage areas, there are clear breaks between sections of cars in case of fire and to enable access. Class A fire damaged vehicles are separate from the main area, no depolluting is being carried out on site. The depolluting garage area is used for storage of batteries and spill kits.

There are four interceptors for the site, paperwork was available showing when they were emptied and the quantities.

The site looks to be in good order and measures are being taken to ensure there is a minimal impact on the environment.
