4. Details of our assessment

General Management and Operating Techniques

An inspection of the paperwork was carried out. The operator was familiar with the paperwork which appeared to be well-organised.

- Records show that inspection and maintenance is carried out regularly.
- Complaints procedures are in place; no complaints have been received since the last inspection.
- Training appears to be up to date for staff; one staff member completed Emergency First Aid at Work course in June, the other staff member is due to complete the course in November.
- Transfer notes were available to show that waste is being disposed of appropriately.
- Feed information showed that the feed is varied over the cycle to reduce phosphorus levels:
 - Starter crumb - 0.62%, Grower 1 - 0.56%, Finisher - 0.53%
- Records are kept to show exports of manure, including date, destination and size of load.
- The operator is aware that NRW require all records to be retained for a 6 - year period.

Permitted Activities

There were no birds onsite on the day of inspection, as the unit was between crops. 49,200 birds were placed in each shed at the start of the previous cycle. Daily crop cards were available for inspection.

The Site

A walk around the site was undertaken; no issues were raised. It was discussed that some water is now coming from a borehole onsite. You should be aware that if daily abstractions exceed 20m³ per day (20,000 litres) you would need to apply for an abstraction licence from NRW, however it seems that currently abstractions are considerably less than this.

It appears that there may have been an issue with your reporting of the 2023 emissions for Ammonia, Nitrogen and Phosphorus. 2. Four Year Review

The four year review into use of energy, water, raw materials and waste materials is due in November 2024. You have been sent a spreadsheet by your Environment Officer. Please complete the form, or collate the relevant information, and return it to your Environment Officer by the end of November at the latest to ensure that you remain compliant with your permit.
