## 4. Details of our assessment

On Monday 9<sup>th</sup> September 2024 Natural Resources Wales officer Ian Thomas attended site.

This was an unannounced routine inspection for permit AP3194FU

On arrival I was met by Keith Williams, one of the owners of H K Motors, the purpose of the visit was to check compliance with the permit held.

The weather was warm and dry. I looked through the relevant documents relating to the permit and the waste regulations in the office, all paperwork and waste transfer notes looked to be in order. Keith was unable to locate the office copy of the permit for the site.

**Action: Please ensure a copy of the permit is kept in the office for reference as is required under the permit conditions. 2.5.2 (EMS)**

The site was tidy and clear, there was some minimal residue of oil next to what looks like a cutting area, this runs into the interceptor for the site and is therefore contained. Please try to minimise any spills or leaks.

The layout of the site is the same as previous inspections with an area where ELV are stacked approx 4 high. There are some vehicles stored around the perimeter of the site on non-hardstanding ground, these vehicles have all been depolluted.

The depolluting garage is clear and tidy, all batteries and fluids are correctly stored and are taken away at regular intervals.

Overall the site is clean and tidy and running well, the last few minor improvements will ensure the site is up to standard and operating in accordance with the permit conditions.
