### 4. Details of our assessment

This Compliance Assessment Report (CAR) follows an unannounced site inspection of Wrexham's Clinical Waste facility on the 12<sup>th</sup> September 2024. Officers met with the Plant Manager and SHEQ Advisor.

Following on from numerous particulate exceedances NRW had discussed with the Operator installing a secondary particulate probe into the stack. Whilst on site the second particulate probe was in the process of being installed. Officers viewed the new port in the stack where the probe is to be located. The Continuous Emissions Monitor readings will need to be downloaded from the probe directly as it won't initially be connected to the Data Acquisition Handling System. Raw data from both the existing particulate monitoring probe and secondary probe should then be provided to NRW.

Following the visit the Operator stated that there was a span alarm on the new particulate probe following its installation and that they were waiting for an engineer to visit site to resolve this.

**Action 1:** Submit the raw CEMS data from both particulate probes to NRW, initially on a weekly basis, starting immediately.

A QAL2 was undertaken at the site during August on the initial particulate probe. The results of this were outstanding at the time of the visit.

Following discussions linked to the waste classification of the sites Incinerator Bottom Ash (IBA), the Operator confirmed that the IBA would be sent to hazardous waste landfill in the interim. The IBA is currently being stored inside the building adjacent to the incinerator where the transfer trailer operation previously occurred.

The Plant Manager confirmed that the bund for the Ad Blue tank was 110% and that the details could be supplied if required. The drainage plan requested as part of CAR NRW0042986 has not been supplied and this is required to understand the drainage arrangements in relation to the Ad Blue tank.

**Action 2:** The drainage plan should be submitted to NRW by 10<sup>th</sup> October 2024.

There were 2 bins within the quarantine area of the site.

**Action 3:** The Operator should confirm to NRW when these bins have been removed from site. Records should be provided for the onward movement of this waste.
