4. Details of our assessment

The routine site inspection was carried out by NRW Senior Officer, Cathrine Kiely and present from the National Trust was Enfys Evans and Carrie Butterworth. Weather during the visit was heavy rainfall and overcast.

The package treatment plant was operational during the visit with no issues identified. There package plant was fitted with an alarm which would alert the operator of any malfunction to the plant. Access to the discharge point was not possible during the inspection but Carrie showed a photo of the outfall which had been taken on 28/8/2024 showing the outfall was clear of any debris or sewage fungus. Advice was provided

regarding maintenance of the tank and that flushing any chemicals into the plant should be avoided. Catering area by Mill Cottages were fitted with grease traps.
