## 4. Details of our assessment

On Thursday the 9<sup>th</sup> September 2024 Natural Resources Wales officers attended site.

This was a routine site inspection for permit ref NB3293HVFL which was carried out by Waste Regulation Officer Ian Thomas.

On arrival at site, Ian met with Lee McKeon, site manager, who accompanied the officer throughout the inspection.

Lee explained that Anthony Williams is the Technically Competent Manager(TCM), and Lee along with some colleagues are in the process of completing their WAMITAB qualifications.

At the time of the visit, the site was not operational due to a breakdown and awaiting parts. The site is still accepting virgin and WRAP protocol materials. A separate bay has now been allocated to store the waste materials from the plant, this material (19 12 09) is then removed. Copies of all waste transfer notes were available in the main office.

All relevant paperwork for the site was inspected and looked to be in good order.

The purchase of the company Roadway Civil Engineering & Surfacing Ltd by Breedon Trading Ltd has still not been completed on NRW's records. The relevant application for this change was returned to Breedon Trading Ltd to complete but has yet to be actioned.

Waste returns have been submitted in line with the requirements of the permit.
