#### 4. Details of our assessment

This is a follow up from CAR\_NRW0044404.

For clarity, this CAR form refers to the operation of Event Duration Monitoring (EDM) equipment for this asset during 2023 but has been completed on the 20/09/2024

Condition 3.1.4 states that "The operator shall take appropriate measures to ensure that the event recorder remains fully operational at all times within the reference period specified in table S3.1. Any failures shall be remedied as soon as reasonably practicable".

The operational time for this asset was less than the minimum of 90%.

It was 0% operational.

Guidance for scoring the non-operational time suggests that this may have had a category 3 – a non-compliance that could have a minor impact on the environment.

DCWW were asked why this non-compliance occurred and what was done to resolve the issue(s).

The primary reason for the non-compliance was a communications issue/failure.

There is poor signal at ground level from mobile network provider and a site survey confirmed the aerial requires raising to improve reliability of data.

DCWW's response to the Corrective action Ref: NRW0044404. For the current year (Jan-September 2024), the percentage of time that the equipment has been operational is 0% and below 90%, therefore we can confirm the EDM at Caergwrle Derby Road CSO is underperforming.

The solution to resolve this issue is a comms improvement plan for this asset. This is part of a prioritised programme of work to improve the EDM asset base reliability. This particular asset sits in priority group No. 1/2 and is forecast to be addressed within the next 5-year period. As mitigation for issues positioned in the lower priorities that are not going to be addressed in the short term, we are carrying out additional maintenance visits to try to manually push through the missing data points to backfill the missing data.

Action: Please carry out improvements outlined in the improvement plan to increase the reliability of data and achieve minimum of 90% EDM data reporting and to notify NRW once the works have been completed.

Action: Until improvement plan has been completed, carry out additional maintenance visits

to try to manually push through the missing data points to backfill the missing data and achieve minimum 90% operational time. As data is 0% for this year, the deadline for this action is 31/12/2025.
