The purpose of this compliance assessment report is to detail the reporting returns for quarter two (April – June) 2024.

Quarter 2 (April – June) 2024 reporting returns

Reporting form A1

The quarterly stack emissions monitoring report for the A1 emission point was received on the 29/07/2024. NO_x was reported well within the permitted ELV. The report is accepted.

Reporting form W1

The water monitoring in relations to discharge point W1

April 2024 – Oil exceeded ELV with a maximum value of 5.29mg/l recorded against an ELV of 5mg/l. All other determinands were within their respective ELVs. However, site reported that no discharge was made to the dock. As such, no non-compliance will be issued.

May 2024 - Oil exceeded ELV with a maximum value of 7.3mg/l recorded against an ELV of 5mg/l. All other determinands were within their respective ELVs. As above, no releases were made to the dock.

June 2024 - Oil exceeded ELV with a maximum value of 10.3mg/l recorded against an ELV of 5mg/l. Suspended solids (SS) exceeded the ELV with a maximum value of 112 mg/l recorded against an ELV of 80 mg/l. As above, Celsa reported no releases were made to the dock.

Oil concentration showed a continued trend of increases in the maximum values recorded, there was also a notable increase in the dissolved nickel during each consecutive month of this quarter. It is appreciated that currently Celsa have not had the need to release any process water to the dock, nor have any releases been made during the last 24 months. However, Celsa should investigate the causes of the increases, ensuring ELVs can be adhered to in the event that a need to release water from the system does arise.
