On 23rd August 2024 a routine site inspection was carried out in the presence of DCWW's Gina Loveland and Geraint.

The arms on the filter bed were rotating freely and evenly.
MCERTs certificate dated; 04/05/2022.

Advice & Guidance

Schedule 3, Table S3.2 states the discharge point is SO 33382 09730.
Unfortunately the outfall could not be located.

It has been agreed that an investigation will be carried out to ascertain this location and ensure there are no issues with the pipe from the treatment works to the river Usk.

A deadline for completion of this works has been given: 23rd October 2024.

I am aware a job has been raised.

Although the outfall could not be located, the surrounding area of the believed location did not have any evidence of sewage fungus, litter, odour or any other visible impact.

Flow data was requested on 27th August 2024 - this will be assessed when received.
