Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

### 4. Details of our assessment

Self reported wirs 2411886 received on 26 August 2024 indicating sample exceedances in respect of Suspended Solids and Biochemical Oxygen Demand (BOD). In house samples were taken on 12 August and the results received by the Facilities Manager on 23 August 2024.

- Suspended Solids sample returned a result of 46mg/l against a permit limit of 30 mg/l

- Biochemical Oxygen Demand (BOD) returned a result of 22 mg/l against a permit limit of 20 mg/l.

As discussed during our telephone conversation of Thursday 29 August, it was indicated that a tanker had been arranged to attend site and empty the system. Also equipment failure was the reasoning for the exceedances and that new equipment was to be installed.

If you could provide me with an update by **Friday 27 September 2024** as to when the new equipment has been installed, that would be excellent.

**Email received from the Facilities Manager on 26 September 2024 confirming the return sludge pump has been replaced at Stackpole Quay.**
