A desktop review of submitted MRF waste returns was completed for the Quarter Apr – June 2018 and Jan – March 2018 returns.

G4 – Monitoring and records, maintenance and reporting – Reporting and Notification to Natural Resources Wales – CAT 4 – EPR Schedule 9 Part 2, Chapter 2, 4(4) and 7

You have been given a CAT 4 breach of the above condition as the input samples were not large enough on average in the Apr-June 2018 returns. With 6 samples taken at a total of 317.09kg, this averages 52 kg rather than the 60kg average required.

The output samples for plastics for both sets of returns scrutinised are consistently showing very large average sample weight. Having previously viewed sampling sheets (CAR NRW0026903 - Nov 2016) it is understood that the correct sample sizes are being completed, however the numbers are being recorded and reported incorrectly.

Both quarters reported an average of 300kg sample sizes rather than the required average of 20kg for plastics. This is a significant difference.

ACTION: Confirm the samples sizes which are being taken by operatives of the plastic outputs.

ACTION: Ensure the average sample sizes are reported correctly.

If you require any assistance with reporting these correctly please don't hesitate to contact me, especially before the next returns are due (end October). It has previously been offered that I inspect the spreadsheet you use to complete the calculations to see if an error can be identified. As yet I have not seen the spreadsheet.

All other calculations appear correct and are being reported correctly.

Any compliance criteria not highlighted in the above summary should be considered as not assessed.
