A routine site inspection was undertaken on Monday 24th September 2018.

Site Inspection

An inspection of the site (yard & building) was undertaken and the following observations were made.

The business appeared to be busy at the time of the visit and it was noted that operations have expanded (within the building).

The yard itself appears to be very well maintained. At the time of the inspection no waste was being stored outside. The parts and items outside in the yard were being stored in a responsible manner. There was no sign of any spillages/leaks of oils/fluids. There was also no cracks/damage in the site surfacing. On-site drainage appears to be working effectively.

Fire Prevention and Mitigation Plan

Thank you for submitting the draft Fire Prevention and Mitigation Plan on 16th February 2018. As mentioned, this will now be reviewed by my colleagues, and feedback will be provided at a later date. The project to review the Fire Prevention and Mitigation Plans for our sites is ongoing and plans for sites with a higher risk are being reviewed as a priority. As the perceived risk on site is considered to be low, and because of the good compliance record for the site, I anticipate it being some time before the FPMP for Partspeed Ltd is reviewed.

We will provide feedback in due course.

Generally, the site is very-well maintained, and no non-compliances were recorded during the inspection.
