4. Details of our assessment

This Compliance Assessment Report (CAR) follows an unannounced site inspection of the 2 Sisters facility at Sandycroft on the 18th September 2024. Officers met with the Engineering Manager.

Officers visited the effluent treatment plant (ETP) area of the site and discussed the effluent discharge. The Operator continues to dose the effluent with DIOX prior to discharge, the dosage has recently been increased following discussions with the Operators consultants. At the time of the visit Officers did not note any issues with the operation of the ETP or the discharge. Dŵr Cymru Welsh Water (DCWW) are responsible for the Operator's trade effluent discharge. Officers continue to liaise with DCWW to aid with compliance.

Whilst on site Officers observed the inside of a refrigerated trailer being washed down adjacent to the rear access gates. It was unclear at the time as to why this was happening. Documentation has been provided following the inspection indicating that ice was being washed from the trailer.

In addition liquid from an offal trailer was being drained directly onto the concrete yard adjacent to the offal gantry. The drain valves were open and the Operator was not following the correct procedure. Procedure OFF001 Offal Gantry and Trailers, dated November 2023, states that the dewatering system trailer valves should be kept shut unless the dewatering system cannot cope or there is a breakdown. The Odour Management Plan states *"The trailer drain valve is opened to allow residual liquid to run out. These are connected to hoses which direct any residual liquids to the on-site foul drain or to a trough which then directs any residual liquids to the on-site foul drain."*

Condition 1.1.1(a) states: The operator shall manage and operate the activities in accordance with a written management system that identifies and minimises risks of pollution, including those arising from operations, maintenance, accidents, incidents, non-conformances, closure and those drawn to the attention of the operator as a result of complaints.

This has been scored a Category 3 breach of Condition 1.1.1(a) General Management as the Operator was not following the correct procedure.

Furthermore the driver of the trailer seemed unaware that this activity was not allowed. There was no supervision of the activity from the Operator. Following an internal investigation the haulage company has stated that drivers will be re-briefed on the process and that they will not drain unless under supervision.

Condition 1.1.1(b) states: The operator shall manage and operate the activities using sufficient competent persons and resources.

This has been scored a Category 3 breach of Condition 1.1.1(b) General Management as the haulage contractor was not trained and the activity was not being supervised.

Action: Ensure all relevant site personnel, including haulage contractors, have been trained in relation to the use of trailer drain valves. This should be completed immediately. NRW may review training records during a future inspection.

This issue of not connecting the trailer drain valves correctly has been raised in a previous CAR, if this activity continues then NRW may review their enforcement position.
