A review of your waste returns for Q1 and Q2 of 2018 has been undertaken. Since this review has been completed on 02/10/2018 you have DE-NOTIFIED the MRF activities on your site.

An email containing the following points was sent on 01/10/2018, and a note made of the replies to these during our telephone conversation on 02/10/2018.

### **Inputs:**

Your inputs have a very large standard deviation.

The sampling methodology has not changed, there is a large variation in the input wastes.

### **Outputs:**

Jan – March, line 14 – sampling is not against a waste code/tonnage/destination

April – June, line 5 – sampling is not against a waste code/tonnage/destination

Sampling had been undertaken however none of this waste was sent from site during this reporting period, the sampling was reported as it had been completed. If however you send this waste out during the next quarter you will need to report this sampling against this output.

Jan – March, there is no standard deviation given for metal and plastics sampling.

Waste returns have since been amended and re-submitted.

The sampling data submitted on the waste returns reviewed meet minimum requirements from the regulations.

Since the site has de-notified you will no longer be required to complete the sampling set out in EPR 2016 Schedule 9 for Material Recycling Facilities. If the company receives above 1000 tonne per year of co-mingled recyclates for separating into the separate fractions, you will need to re-notify us of this activity and recommence sampling as per the regulations.
