4. Details of our assessment

Site Inspection 24th September 2024.

At 9:30 on the 24th September 2024 a site inspection was undertaken by NRW officers Phil Harper, Senior Industry & Waste Regulation, Jim McClymont, Industry and Waste Regulation team leader and Sara Pearson, Operations manager North East.

This visit was in part undertaken in partnership with officers from the Health and Safety Executive (HSE).

The site manger and health and safety manager for Synthite also accompanied the visit.

General Site Condition

A general site walkover was undertaken. The site has been visited frequently since the 30th April 2024, no further issues were identified during this inspection.

Works have been undertaken on the sites groundwater monitoring boreholes, which are now visually equipped with sealed caps or surface completions depending on their location. No boreholes were opened for inspection during this visit.

Covers have been replaced on the cooling tower adjacent to the chemicals production area, drastically reducing the amount of water leaking from the unit. Some small leaks were still evident. Officers were informed that plans were in place for the replacement of the cooling tower with a modern cooling tower.

The height of the concrete containment wall at the lower site has been increased. Officers understand that water stops have been used to ensure that the new wall section is sealed to the original wall. The site is waiting for a higher drop beam to allow for access to the lagoons.

Standing water was visible around the formaldehyde plant. Construction works are still ongoing for the new formaldehyde plant, currently preventing access to the site drainage for remediation works. No standing water was observed at the lower site.

Lagoons

At the time of the inspection the sites effluent lagoons were inspected. The lower and upper lagoons were well below the top of the liner, no breaches of containment were evident.

Pipework around the lagoons have been labelled as recommended by the previous compliance assessment report.
