### 4. Details of our assessment

Routine inspection of Llangyndeyrn wastewater treatment works which is fed by pumping station & gravity feed also. screened at inlet to works with a 6mm Spyrack screen. A compacter is used at this point with rag to skip/bin and disposed off site. a storm overflow option is available at this point which goes to a storm holding tank with overflow to the Gwendraeth Fach.

EDM monitoring point to storm tank and monitoring following settlement tank to count spill

events. Air blower on primary. filter bed has some moss growing on the filter media as a result of DCWW being unable to use herbicide. a waterwheel filter arm is in use with operatives advising that the system works well. site visited 3 times per week by operative routinely.

Unable to inspect outlet point from DCWW works or NRW owned area with Hydrometry gauging instruments. Fish were visible in the watercourse at this point. to inspect the outfall it is necessary to enter private agricultural land. Final effluent point inspected and sampling parameters well within permit conditions with no permit breaches reported within last 12 months.

28 block counted spills going to storm with 19 events classed as significant.
