4. Details of our assessment

BP0287701

On 09/05/2024 officers visited Afan WWTW and inspected the site for compliance with the associated permits – BP0284701 (Secondary Treated FE), BP0287601 Settled Storm and BP0287701 Sewage in an Emergency. This inspection was performed as a part of the 2024

Bathing Waters Inspection Program.

This report relates to BP0287701 Sewage in an Emergency but should be considered alongside the other reports Refs;

BP0284701 (Secondary Treated FE) – CAR_NRW0045325

BP0287601 Settled Storm – CAR_NRW0045326

At the time of inspection this emergency overflow was not in operation. Following a discussion about the overflow the officers ask that the operators provide clarification on the following points by 31/10/2024;

1. A confirmed location of discharge for this emergency overflow. The permit suggests that it is at the rear of the pumphouse (W3W - ///heads.slices.crackling) however discussions indicated that this may be through the Long Sea Outfall associated with the FE and SS discharges.
2. In the event of a power failure, how would this discharge be screened as per the permit requirement in Condition 6.
3. Please explain if / how the tide may affect this discharge if / when it is in operation. Is it possible for this overflow to become hydraulically locked by tidal influence.
4. Please provide details of any telemetry / EDM recording for this overflow.
5. Please confirm if an external pumping equipment facility is provided at this site as per Condition 14.
