4. Details of our assessment

BP0284701

On 09/05/2024 officers visited Afan WWTW and inspected the site for compliance with the associated permits – BP0284701 Secondary Treated FE, BP0287601 Settled Storm and BP0287701 Sewage in an Emergency. This inspection was performed as a part of the 2024 Bathing Waters Inspection Program.

This report relates to BP0284701 Secondary Treated FE but should be considered alongside the

other reports Refs;

BP0287601 Settled Storm – CAR_NRW0045326

BP0287701 Sewage in an Emergency – CAR_NRW0045321

At the time of inspection, the site was operating normally. At the inlet works, of the three pumps 2/3 were in service, one had recently been replaced, with one old in place and one (Hire) out for service/maintenance. It was also noted that seven of the eight SBR have now been refurbished.

Officers and operators discussed the nature of the sites dual power supply (required under permit), a number of points still require further clarification, as such please could you provide the following information by 31/10/2024;

1. A detailed description of the dual power arrangement.
2. A map or schematic identifying the points on the power grid from which the two sources.
3. Confirmation/evidence from the power provider/network operator of the above arrangement.
4. Consider the feasibility of providing backup power for the inlet screens and feedback on this.

With regard to point 4, we would welcome a wider discussion on power once the above information has been received.
