On 09/05/2024 officers visited the Abbey CSO & EO overflow and screens within the Afan WWTW site and inspected the structure for compliance with the associated permit – BW0202801. This inspection was performed as a part of the 2024 Bathing Waters Inspection Program.

Officers did not observe any non compliances at this part of the Abbey CSO / EO system. It was noted that the screens were due to be serviced and have new brushes installed. Officers were also informed that the maintenance a checking of these screens has as of the time of the inspection been passed to the team running Afan WWTW. Please confirm if this work is now complete by

31/10/2024.
