Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution or civil sanctions being imposed depending on the circumstances of the offence.

At this time, we do not intend to take any further action.

4. Details of our assessment

I attended site on the 3 September 2024 on an unannounced inspection, the weather was showery clearing to

warm sunny spells. Some heavy rain in the preceding few days had raised river levels.

Note this CAR for also applies to Abstraction WA/059/0001/010 and Impoundment WA/059/0001/011.

Heading up the hill I identified the scheme, though there was significant vegetation in the watercourse that may have affected flows over the scheme. There were signs of recent clearance to maintain the scheme. The scheme did not match the drawn design in the permit so I took measurements and NRW's Hydrology team have confirmed the scheme is compliant.

ACTION: Vary the permit to accurately represent the built design.

I then headed down to investigate the area of the older permit WA-059-0001-011, and identified the historic structure and pipework, which was still in situ in the watercourse – though not abstracting as the flow was passing through the weir and the pipe had been cut short. This is in breach of the permit condition 4.7: *“Prior to commencement of the works authorized by this licence, the Licence Holder shall complete the work to remove the existing unlicensed impounding works at National Grid Reference SN 82640 13190 as authorised by licence number WA/059/0001/011.”*

ACTION: Complete the removal of the historic structure as detailed in the authorised method statement associated with the permit no later than the 30 April 2025. Please note that in-river works should not be undertaken between mid-October through to March so these works should be undertaken outside of this window when river levels are suitable.

If this is not possible within the given timescale please contact me to discuss and extension.
