4. Details of our assessment

This compliance assessment report is being produced following a site inspection conducted on Friday 13th September, by Luke Taylor and David Fowles of Natural Resources Wales.

This was an unannounced inspection, the weather at the time was dry and bright, and the officers were accompanied by one of the sites Technically Competent Managers (TCM), Stuart Dunseath.

The de-pollution bay was checked and found to be free from any evidence of spillages. Waste oils are pumped from the bay to a storage tank elsewhere on the site. Other hazardous waste liquids, such as coolant, brake fluid etc are being stored in labelled, suitable containers, pending removal from site. No mixing between hazardous and non hazardous waste types was identified.

The waste oil tank was checked and there were no signs of any leaks or spillages, with the concrete bund in good condition.

The continued competency certificates for both the site TCM's were up to date and displayed.

The site environment management system, referred to as the working plan due to the age of the permit, was available but not fully reviewed during the inspection. This will be reviewed as part of future compliance work.
