4. Details of our assessment

On 21st September 2024, A routine OSM sample was taken which exceeded the allowable limits for Ammonia (Determinant 111), as described within the emissions and monitoring schedule of Permit AW1005301 (Schedule 3 and 3A). The sample contained 8.85 mg/l Ammonia, with an allowable limit of 8mg/l.

This was the first sample exceedance for Ammonia within in the past 12 months. Records show that 12 Samples had been taken within the previous 12-month period. The OSM look up table (Schedule 3A) details that with 12 samples taken within the past 12 months, the allowable number of exceedances is 2. Therefore there is not currently a breach of permitted conditions.
