### 4. Details of our assessment

I (Environment Officer Gavin Dodd) arrived at Ffrwd fish farm, Maesycymmer on Wednesday June 19<sup>th</sup> 2024 at 10:00 to conduct an inspection regarding a licence to abstract water from underground strata (Permit Number 21/57/12/0096). Site manager Andrew Sweet was also in attendance.

The source of the supply was a borehole 55m in depth, with electric pumps underground. The authorised place of abstraction was at ST 1558 9229, as specified in the permit. The purpose of the abstraction was for water to be used in the fish hatchery and then as a through flow to the fishing lakes; Mr Sweet mentioned that the water was not currently being used in the fish hatchery.

Monthly readings were taken to monitor the amount of water being used, though these were not available on site. Mr Sweet stated that less than 60 cubic metres a day were being used currently. A turbine meter was installed on the system, though this was installed some time ago and has not been calibrated. The period of abstraction is all year.

### **Breaches**

**1.) Condition (g)-** The licence holder shall maintain the meter in a condition so as to measure quantities of water abstracted accurately and efficiently, shall calibrate it regularly.

**Justification:** No calibration certificate for the meter was available.

**2.) Condition (h)-** The licence holder shall take and record readings of the meter specified in condition (g) at the same time each day during the whole of the period which abstraction is authorised.

**Justification:** Abstraction records for the licence were not available on site.

### **Actions required by dates specified**

- 1.) Calibrate the meter to ensure readings are accurate.
- 2.) Provide abstraction returns for the past six months.

**The deadline for the above actions is 30<sup>th</sup> November 2024**
