4. Details of our assessment

This was a routine unannounced inspection. The weather was dry and overcast at the time

of the inspection.

This impoundment is associated with abstraction licence MD/054/0001/060.

The facility was inspected and found to have been constructed not in accordance with the recorded plans. The head wall has been rotated by approximately 80 degrees counter-clockwise. However it is not felt that this will have significantly altered the impact to the watercourse.



The compensation flow notch was found to be blocked with a clump of vegetation, preventing compensation flow. There was also a concrete kerb over the top of the compensation flow notch where the construction drawings show the notch to be open above. This issue needs to be resolved by the site operator, a due date for improvements has been set at 11/11/2024, which is sufficient time to carry out the maintenance required.



The facility did not appear to be abstracting water at the time of the visit, so there was no impact to the flow downstream of the impoundment.

The intake screen looks to be clean and well maintained, and there was a brush nearby suggesting that the facility is checked reasonably often. During these checks the operator should ensure that the compensation flow is kept clear.
