4. Details of our assessment

This was a prearranged site familiarisation visit undertaken by Natural Resources Wales (NRW) regulating officers.

A short introductory meeting was held with facility representatives, before NRW officers were accompanied on a tour of the facility. The site was operational at the time of the inspection.

The salient points and observations from the introduction and tour are as follows:

- At the time of the inspection the facility was in a clean and well-maintained condition.
- Raw materials and products were segregated on the site and stored both within the manufacturing warehouse and externally in the storage yard. Internally materials are stored on racking or directly on the concrete floor. There are no drainage points internally. Externally standard international bulk containers (1000litre IBC) were stored on racking systems which were positioned within the bunded area. All external bulk tanks were located within concrete bunds. Three of the bulk tanks were observed to be labelled as "empty and not in use". The operator confirmed that they are planned to be removed from site when budget and resource allows.
- Dedicated hose drip trays have been introduced for each bulk tank. The drip trays are located outside of the bunded area where they are at risk from being damaged by forklift truck movements.
- A detachable flood barrier has been installed across the entrance to the manufacturing warehouse to minimise the risk of liquid product flowing into the warehouse in the event of bulk tank failure. The barrier does not extend to an area of permeable ground, which along with the underlying strata would at risk in the event of tank failure.
- A previous CAR (see CAR reference NRW0042008) required that the failed drainage adjacent to bulk tank bunded area was to be replaced. On site observations confirmed that the work had been undertaken as required.
- The required improvement to the secondary containment around the bulk hydrochloric acid (HCl) tank (as required by CAR_NRW0040313), is scheduled to be commenced November 2024.

Actions

1. Relocate the hose drip trays to within the bund and provide confirmation to NRW by **31 October 2024**.
2. Investigate a means of protecting the permeable ground adjacent to the warehouse entrance in the event of a tank failure and report to **NRW by 30 November 2024**.
3. Provide confirmation to NRW that the upgrade to the HCL bund has commenced and include the planned programme of works to completion by **30 November 2024**.
