## 4. Details of our assessment

### Introduction

Tata Steel UK Limited (TSUK) operates the Port Talbot Steelworks in accordance with the environmental permit EPR/BL7108IM.

### Scope

Natural Resources Wales (NRW) have undertaken a review of the TSUK's Improvement Condition Programme following the closure of the heavy end operations.

This Compliance Assessment Report (CAR) is pertinent to the Improvement Condition (IC) Programme included within the environmental permit. Namely, the contents of this CAR will address the outstanding IC12 of this programme.

### Improvement Condition Programme – IC12

The Improvement Condition Programme is included within *Schedule 1: Table S1.3* of the permit, the completion of these by the specified dates are a requirement of permit condition 2.5.1.

An extract detailing IC12 is illustrated below.

*In relation to the upgrade of the internal power generation facility (Power Station) the Operator shall inform Natural Resources Wales of the date of cessation of operation of the following:*

- a) Service Boilers 4 and 5 (A50) (LCP 337);*
- b) Boiler 5 (Margam A) (A51) (LCP 339); and*
- c) Mitchell Boiler (Margam B) (A53) (LCP 338).*

*To enable Natural Resources Wales to inform Defra and / or the Environment Agency of the need to modify the Transitional National Plan.*

The site's heavy end operations underwent decommissioning as of the 30<sup>th</sup> September 2024. The A5 Boiler (A51) and Mitchell Boiler (A53) were decommissioned as of 1<sup>st</sup> of July 2024. Service Boilers 4 and 5 (A50) are not yet decommissioned (date of decommissioning is to be confirmed to NRW).

IC12 requirement relates to the Transitional National Plan (TNP). The TNP started on 1<sup>st</sup> of January 2016 and continued until 1<sup>st</sup> of July 2020. As the TNP has now concluded, IC12 is considered to be no longer relevant and subsequently has been closed out.
